### **John Textor está en Liverpool para realizar conversaciones adicionales con el dueño del Everton, Farhad Moshiri, sobre una propuesta de 5 adquisición del club; se espera que se acuerde un trato para fin de semana**

El multimillonario estadounidense se convirtió en la 5 tercera parte en ser otorgada un período de exclusividad por Blue Heaven Holdings, la compañía que posee al Everton, la 5 semana pasada después de renovar sus esfuerzos por adquirir una participación mayoritaria en el club de la Premier League que 5 había sido previamente descartado por Moshiri a favor del Grupo Friedkin. Ellos habían acordado comprar la participación del 94.1% de 5 Moshiri, pero se retiraron sobre las preocupaciones sobre las incertidumbres legales que rodean los £200m en préstamos que 777 Partners, 5 la primera compañía en acordar un takeover en septiembre, dio al club. Se entiende que un préstamo de £200m hecho 5 al Everton por el Grupo Friedkin durante su intento de adquirir el club está programado para ser reembolsado.

Textor, cuyo Grupo 5 de Fútbol Águila ya tiene participaciones en Lyon, Botafogo Molenbeek y Crystal Palace, se entiende que llegó a Londres el 5 martes antes de viajar a Liverpool el miércoles para conocer a Moshiri, con fuentes cercanas al trato anticipando que podría 5 acordarse en los próximos días.

Los términos son los mismos que en la oferta presentada el 1 de junio en la 5 última ronda de ofertas, con Textor entendido que está confiado en que puede organizar un acuerdo de financiamiento para el 5 nuevo estadio del Everton en el muelle Bramley-Moore, lo que le permitiría retrasar la finalización del takeover hasta enero.

Una posible 5 complicación podría ser la necesidad de Textor de vender sus acciones del 45% en Palace para cumplir con las reglas 5 de la Premier League. Se entiende que una oferta de sus compatriotas Josh Harris y David Blitzler, quienes ya poseen 5 el 18% de las acciones de Palace, por alrededor de £100m ha sido rechazada. Tres inversionistas más se cree que 5 han expresado un interés en comprar las acciones de Textor, incluido uno del Medio Oriente y otro supuestamente un grupo 5 de celebridades deportivas apoyado desde los EE. UU.

La semana pasada, el presidente del Palace, Steve Parish, dijo que no se 5 interpondría en el camino de Textor después de que pagara £87.5m por una participación del 40% en Palace en 2024 5 antes de extenderlo al 45% cuando compró Lyon un año después. "Él quiere un club que se conecte con eso 5 donde controle todo lo que sucede. No pensamos que eso es correcto para nosotros como un club en este momento", 5 dijo Parish a la . "Colaboramos con sus clubes donde

podemos. Él quiere ir y hacer algo más, estamos ayudándolo 5 a hacer eso."
